Drivers were asked about their preferences in refueling at Pemex and other brands, the regulations applicable to platform-dispatched taxis (PDT), and their expectations regarding the cleanliness of bathrooms at the gas stations of Pemex and other brands. The report comments on PDT brands other than Uber, such as Didi, a Chinese platform whose app works in Mexico but not in the United States. The authors observe that while creative destruction has been successful in the traditional taxi market, there are other markets, such as residential natural gas, where the legacy model prevails.

What was supposed to have been a success story by an oil company operating independently of Pemex was forcibly reshaped to be an asset majority-owned and operated by Pemex. The report concludes that no reform will deliver on its promises so long as the President has any role in the naming of the executives of Pemex or CFE.

The first of these concerned civil aviation, the second, diverse administrative proposals meant to tighten the Executive's effective authority over the federal government. Of 23 such bills, a dozen concerned limits on the salaries of public officials. The others would confer new faculties on the president, also define situations in which government contracts to private parties could be canceled or rescinded. While the bills contained nothing about hydrocarbons or energy regulators, they were present in their penumbrae, posing new risks for investors.

Talos's situation is complicated by a ruling of the Energy Ministry in 2021 that assigned Pemex as the operator with 50% and a fraction ownership of the commercial rights to the reservoir. In this report, we examine the issues that must be resolved for the parties to reach a Final Investment Decision (FID) to move forward with development.
